Corrigendum issued in reference of the earlier Notification No. Affiliation/2017-18/1362 dated 01-12-2017

NOTIFICATION

Notified that the University Considered accepted the Report of the Endowment Fund Review Committee as per the facts give below:

- 1 UGC Structure for Endowment Fund as suggested in the GAZETTE OF INDIA, FEBRUARY 20, 2010 CLAUSE 3.2.2.: (Which decided the Endowment fund for whole country)

Fund in Rupees	Per Programme
15 Lakhs	Arts, Science , Commerce
35 Laks	Professional Programme subject to the limit laid down by the concerned Regulatory Body.

- 2 Though it is a mandatory provision for all the universities of the Nation but the Rajasthan University reviewed the same. Here it is to be noted that the Rajasthan University Affiliation Rules No. 1.2.2 also endorses the structure suggested by the UGC in this regard. The Committee considered the resolution number 15 of the Academic Council of the Rajasthan University considering the New Rules of Affiliation for private colleges based on the Affiliation of Colleges by the Universities Regulations, 2009 where under decided the endowment fund as under:

Fund in Rupees	Per Programme
5 lakh	Arts, Science, Commerce
10 Lakh	Professional Courses like BBA, BCA, LL.B & others

- 3 The committee considers it a fairly reasonable amount keeping the purpose and nature of the endowment fund in mind since this is founded on the "Affiliation of Colleges by the Universities Regulations, 2009" as well as by the "Rajasthan University Affiliation Rules". Therefore, the Committee accepted it as a general rule. **The University has no authority to disturb this structure.**

4 Notified Recommendation:


Notwithstanding any thing in the earlier orders/ notifications the University accepts/recommends the following structure of the endowment fund for the purpose of this academic session (Since the University does not have authority to disturb the UGC Regulations):

Fund in Rupees	Per Programme
3 lakh	Arts, Science, Commerce
3.5 Lakh	Professional Courses like BBA, BCA, LL.B & others

Note 1: "Programme/Programme of Study" means a higher education programme pursued for the degree specified by the Commission under Section 22(3) of the UGC Act. (This has been defined under Section 2.5 of the UGC [Affiliation of Colleges by Universities] Regulation, 2009). This has been circulated by the UGC vide letter No. F.1-7/2007(CPP-I) dated 29.04.2010 and published in the Gazette of India on Feb. 20, 2010.

Note 1-A: The said "programme(s)" have been listed lastly, under Section 22 (3) of the U.G.C. Act has been published in the Gazette of India on July 5th, 2014.


